

Cancer Drugs

The death causing terminal diseases of cancer is used to rationalize and justify the use of cancer drugs. It is emotionally felt that anything that can save a life should be done to save a life. Cancer drugs, are felt to be needed in a life or death situation.

Dangerous cancer causing cancer drugs are exempt from being banned because saving someone's life is more important than the danger of the drug.

The cause of cancer is scientifically unknown and there are many definitions for classifying disease as cancerous in addition to many treatments to get rid of cancer. The specific cause of cancer is unknown and yet cancer is treated with specific drugs. Since, there is no specific cause there cannot be a specific drug treatment.

Consequently, since there is no specific cause, this allows the drug companies to use any type poison medicine. This is similar to you dressing for the possibility of hot, cold, windy, rainy, snowy, or stormy weather without knowing the type of weather. Added to this you are unaware of whether you are going outside or staying inside and yet you dressed for the possibility of the weather types while remaining indoors, completely dressed in multiple types of clothing.

Cancer's medical definition changes, and effectiveness of drugs have not had clinical trials. The drugs and treatments are designed to justify the drug company's sales of the drugs and equipment as well as profit-making research industries. Drug laboratory experiments of the safety and therapeutic use of drugs are ceremonies used to justify (Justice) their sales.

This is the same as courts using "The Law" and "Justice". Rituals and ceremonies that are punishable with a fine or jail term if not followed are called "The Law". "The Law" can be twisted or circumvented, abused, denied due process and manipulated. "The Law" and "Justice" are two different things.

Justice means "Just" your purpose, desire; wants or needs are being served, Therefore, "The Law" is used to give you "Just (Justice)" what you want. Your "Justice (selfishness)" can be bipolar. This means it can accidentally serve others (selfish) needs. A court of law is a set of ceremonies used to enforce rituals (Laws) that you use to get "Just (Justice)" you're needs met People believe in "The Law", but they only want their needs met or "Justice". Drug research and laboratory rituals are used to get them "Just" profits. Therefore, cancer drugs that are given to a healthy person will make them sick and can kill them aside from giving them cancer. The cancer disease justifies the use of cancer drugs. Having to kill a person to make them healthy is the "Just" reason for giving the drug.

The cancer drugs attempt to target specific cell functions and cells. How some cells get cancer and some cells do not get cancer is unknown. Cancer can be of the external and internal skin (epithelial), which has no blood vessels and cancer of the glands and ducts.

This is called carcinoma cancer. Sarcoma cancer is cancer of the connective tissue, which originally grew from the embryo (very young fetus) mesoderm tissue.

Cancer drugs are usually antineoplastic which prevent the growth and development of cells, particularly malignant (harmful) cells. Cancer drugs can also be alkylating drugs, which are hydrocarbons used to destroy DNA (genetic code) causing an imbalance of cell growth that leads to the death of the cell.

The Antineoplastic, Anti-metabolites, Antibiotic, Hormone Altering And Alkylating drugs have the same side effects.
